### A Day at the State Capitol - Update

As you receive this newsletter, it is likely that the First Regular Session of the 131st Legislature will have adjourned. In the May newsletter, I reported on the public hearing for three proposed bills dealing with firearms legislation.

The Maine Democratic Party has included a statement on gun ownership in their Platform: "We believe in preserving our outdoor heritage and in maintaining responsible and accountable gun ownership, including universal background checks, while protecting the safety of all Maine people. We believe that gun safety measures are compatible with Maine's long-standing tradition of hunting and firearm ownership."

Here is an update on the current status of the three bills.

# LD 22: Sec. 1. 15 MRSA §394 "An Act to Impede the Transfer of Firearms to Prohibited Persons"

Sponsored by Sen. Anne Carney and co-sponsored by Senators Pinny Beebe-Center and Mark Lawrence, and House Representatives Vicky Doudera and Erin Sheehan.

Passed and signed into law by Governor Janet Mills, June 26, 2023.

It is now a class D crime to "knowingly or intentionally sell or transfer a firearm" to people who should never own or possess guns under the law, with the exception of

#### LD 60: "An Act to Require a 72-hour Waiting Period After the Sale of a Firearm"

Sponsored by Representative Margaret Craven and co-sponsored by Representatives Arford, Crafts, Dodge, Gramlich, and B. White.

LD 60 has been placed in legislative files (DEAD).

This bill would have slowed the transfer of a firearm from seller to buyer. Advocates noted a marked decrease in suicide by gun in states where this waiting period is in effect. Critics pointed to the delay as an infringement on second amendment rights and possible endangerment to individuals needing self defense.

This bill was referred out of the Criminal Justice and Public Safety Committee with a divided report; the majority opinion of "Ought to Pass as Amended" gained 7 votes out of 13. However it failed to pass the House on a vote of 69 Yeas to 73 Nays with 7 absent. On June 15, it failed to pass the Senate with a vote of 11 Yeas to 24 Nays. Of our local Knox County Democrats, Yea votes were cast by Senator Beebe-Center and Representatives Doudera, Geiger, and Zeigler, with Matlack absent. A Nay vote was cast by Senator Cameron Reny.

# LD 168: "An Act Regarding Criminal Background Checks for the Sale, Transfer or Exchange of Firearms"

Sponsored by Speaker Rachel Talbot Ross and co-sponsored by Representative S. Salisbury.

This bill was intended to close a loophole in the law. Currently, commercially licensed firearms dealers are required to secure background checks of buyers. This bill would have also required private sellers (such as those on the internet or at gun shows) to secure a background check.

The bill was referred to the Criminal Justice and Public Safety Committee and

"Passed to be Engrossed" [This phrase indicates the bill was passed with an amendment] with 2 House amendments. The House vote on June 26 "Ought to Pass as Amended" was extremely close, 69 Yeas to 68 Nays. All four Democratic House Representatives from Knox County voted Yea.

The Senate acted on June 27 voting to reject the motion to pass as amended by a vote of 13 Yeas to 21 Nays. Of our two Democratic Senators representing districts in Knox County, Senator Beebe-Center voted Yea and Senator Reny voted Nay. The House subsequently voted not to concur with the Senate. It is unclear if any further action will be taken by House or Senate.
